 - Amending the continuing resolution on FY 2025 budget and amount OMB approved
 - Capital Outlay Funds for County Rd 1 in amount of \$4.7 million to chip seal.
 - Currently, there are 1.2 million to plan, design, and construction of new a chapter. Additional funds are needed.
 - Hire 2 PEP workers for the Christmas Dinner.
- > Walter Hudson inquired and commented with ideas.
 - PEP worker
 - Student/youth employment and budget
 - Warranty on grader. Documents from 2018 sufficient and supporting. When purchased? If it has expired.
 - DOJ to regain documents.
 - ARPA and procedures to access.
- > Jay Chee responded that an amended resolution was drafted. ARPA/RRR. PMD has been giving us excuses.
- ➤ Lester Ashley asked why the PEP workers do not receive their paychecks until Monday not on Friday. He went to say the chapter has a lot of money and to give it to him so he could



- spend it. Grader needs tires. The equipment has been neglected while it was parked outside exposed to the elements.
- Jay Chee explained that the chapter officials and he are still revising the policies. The Monday payment will be corrected with policy revision.
- ➤ Walter Hudson made suggestion for chapter community members to spend the 8.1 million dollars.
 - There are 3 types of funding, FY 2025 Budget, FY 2024 Carryover and ARPA(RRR).
- ➤ Della McCrea made a comment that the officials listen, and the community members are boss. CSC is doing a good job by teaching an adjournment method. Stated again the PEP workers to have jobs for 1 year.
- Dorothy James has windows and a door that needs installation.
- Marvin Tom came with his brother Ronald Tom. Marvin is asking for Housing Discretionary funds and had come to the chapter house. He also wanted a Verification of residence. He has been to Continental Divide to powerline hookup.
- > Jay Chee wanted to know if he has a structure for the powerline hookup. Answer is no.
- Marvin explanation finally made sense. He had a structure, and it was falling apart and was dismantle. The powerline has been put up on the pole. He wants to build another structure. He has a homesite lease. Davina Spencer will assist him with the land status. There are no Housing Discretionary funds till March 2025.
- > Lester Yazzie's reported on:
 - Veterans agree on funds.
 - 6 months continuing resolution.
 - B&F
 - Land board livestock is sacred.
 - Indian Health Service with water coming. Nygren signed the reservation wide to add bathroom addition.
 - 235 million divided by 24.
 - Sewer treating, convenient gas stores.
- Walter Hudson made comments on how to spend the funds from Sishasin, ARPA (RRR) and Capital Outlay. He talked about Cameron chapter getting a new chapter within 3 months.
- > Elizabeth asked for assistance with the survey and made a motion to adjourned.
- > Della McCrea said you can leave, I still have questions. She suggested the following:
 - Catered food for Thanksgiving, Christmas, and New Year's dinner.
 - PEP worker to chop wood for elders.
 - Wood voucher.
- > Jay Chee agrees with Della. Wood chopping by PEP workers has liability and insurance safety issues.



- Davina Spencer helps with compliance. She encouraged more participation of community members. She mediates and advocates for the permit holders. She is still performing tally counts. The land board has asked for no increase on the grazing fees.
- ➤ Walter Hudson said there is an increase in the price of pour on. Maybe, the chapter may set an account for cost share for the permit holders. There are 14 in the area.
- > Jay Chee explained the policy review and procedures.
 - Internal audit soon.
 - Giving hard time to community members.
 - Cancel the contract of new chapter with vice-president's signature.
 - Plan, design, and construction of new chapter. Have 1.2 million for the new chapter.
 - Looking for documents.
 - Heavy Equipment.
 - Chapter compound fencing and resurvey.
 - CHR, AMS, OS are 8-5 employees. They are not mandated and are exempt.
 - Coal delivered.
