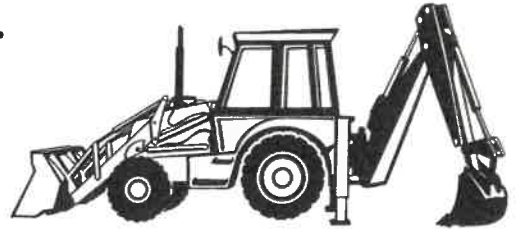


## Tsayatoh Chapter Grader/Backhoe SERVICE FEES

**Notice:** Must be a registered voter with Tsayatoh Chapter in order to be eligible for residential rates.
