- Guarena Adekey reported during the resolution item discussion that projects are moving forward at Window Rock.
 - 8 names are on the Powerline list.
 - 12 names for the House Wiring list.
 - There are no contracts assigned to these projects.
 - Three NM State fundings will not br reauthorized.
 - Four hundred thousand dollars will be utilized to cover all projects that are moving forward.
 - 2 names for bathroom addition.
 - Office Assistant, Quiency is resigning.
 - \$535.45 is to buy food from Anthony's of Southwest for District 6, 2025 meeting on May 29, 2025. This is to feed the District 6 chapter officials, District 16 Land Board members, and CLUPC members.
- > Lester C. Yazzie gave his report:
 - Navajo Nation White House and Funds.
 - NM State funds and projects
 - Land Withdrawals.

- COLA increase by 3% for Navajo Nation retirees.
- Guarena reported that she and Regina Martinez happened to be at Anthony's. They discussed having a meeting on Hunter's Point Road which is deteriorating.
 - Four hundred thousand dollars will be used for projects. There might be a shortfall.
 - Jennie Ape and Corrine Morris are on bathroom additions project is moving forward.
 - New chapter has a change in the scope of work. Plans are done. Design phase and construction will require additional fundings. Chapter officials and ASC will apply for funds through TIF.
 - Solid Waste not feasible because the chapter does not have CLUPC. The chapter
 officials may be CLUPC members. The announcement for CLUPC interest has been
 advertised for 4 weeks and no one has applied. It pays a stipend of \$115.00 a month.
 - Cemetery family plots have to visit the Land Department to fill out applications.
 - June 18, 19, 20, 2025, the chapter is having a follow up audit. If the audit has a finding of 79% the chapter will be sanctioned. It if passes with 80% the chapter will not be sanctioned. Vice-president is assisting with the property list.
 - June 16, 17, 18, 2025, newly elected officials who did not attend the orientation in March will attend the orientation at San Juan College in Farmington, New Mexico.
 - CHID is working on work order #3.
 - NNDOT meeting on June 12, 2025 at 9:00 AM.
 - Kathleen Arviso, Land Board, made her report.
 - Cemetery family plots need to visit General Land Department in Window Rock.
 - Biological clearance is required. New one 4 Acres or more need to have a consultant. Not sensitive, not too much sensitive and very sensitive.

 - BIA is still completing range inventory and has not issued out the permits.
 - District Land Board meeting on July 11, 2025.
